If you assume that growth will be 1 percent, it will take considerably longer than ten years to get back to the pre-COVID levels of GDP and employment. US GDP growth is generally lower than it was in prior decades because of slow growth in the labor force growth is slowing, and productivity growth rates are also lower than they were in prior decades. While quarterly growth rates or employment increases might be volatile in the recovery from the very steep drops in 2020 Q2, it is hard to see them adding to 4%+ annual growth in GDP or employment that would be needed to give us the quick fix or what has been called a V-shaped recovery.
